

S&P SL20 gains 1.1% for the week

ASPI closed in red as a result of price losses in counters such as Ceylon Cold Stores, Sri Lanka Telecom and Sampath Bank. A similar behavior was witnessed in S&P SL20. Meanwhile, the turnover crossed Rs 351 Mn for the day. High net worth and institutional investor participation was witnessed in People's Leasing & Finance and People's Insurance. Mixed interest was observed in Teejay Lanka and United Motors Lanka whilst retail interest was noted in Lanka Century Investments and Lankem Developments. Meanwhile, foreigners closed as net sellers mainly due to foreign selling in People's Leasing & Finance and Teejay Lanka.

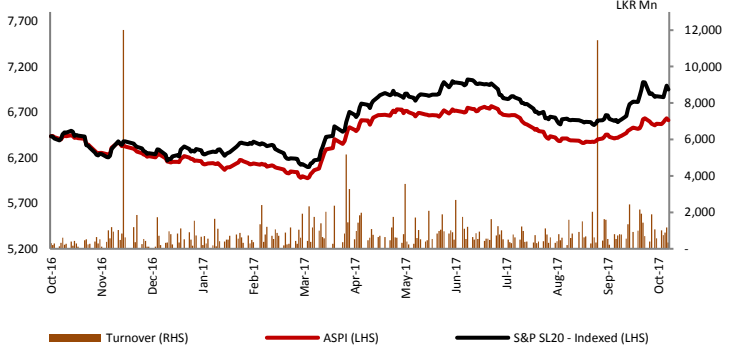
During the week, ASPI and S&P SL20 gained 0.61% and 1.07% respectively.

Banks, Finance and Insurance sector was the top contributor to the market turnover (due to People's Leasing & Finance and People's Insurance Limited) whilst the sector index lost 0.46%. The share price of People's Leasing & Finance increased by Rs 0.30 (1.74%) closing at Rs 17.50 whilst foreign holdings decreased by 3,000,000 shares. The share price of People's Insurance Limited lost Rs 0.50 (2.00%) to close at Rs 24.50.

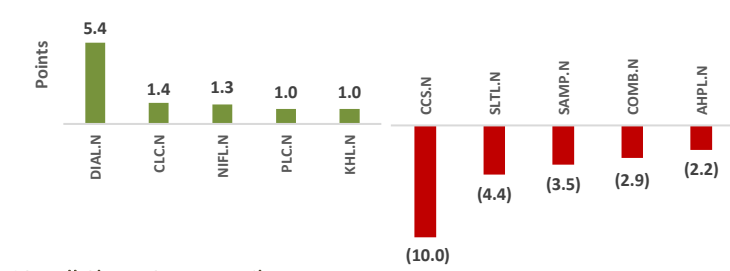
Manufacturing sector was the second highest contributor to the market turnover (due to Teejay Lanka) whilst the sector index decreased by 0.45%. The share price of Teejay Lanka moved down by Rs 0.50 (1.29%) closing at Rs 38.40 whilst foreign holdings decreased by 402,633 shares.

United Motors Lanka and Ceylon Guardian Investment Trust were also included amongst the top turnover contributors. The share price of United Motors Lanka recorded a gain of Rs 1.30 (1.73%) to close at Rs 76.30. The share price of Ceylon Guardian Investment Trust increased by Rs 3.10 (3.20%) to close at Rs 100.00.

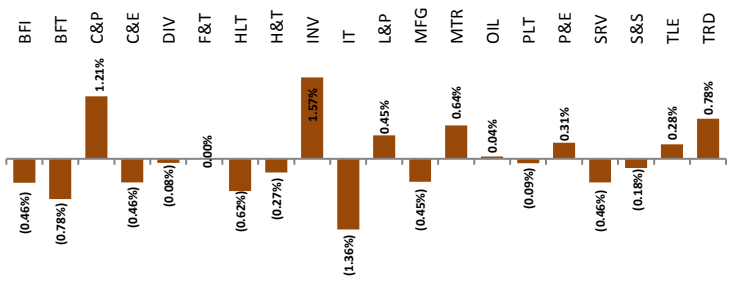
CSE Equity Market Performance – One year



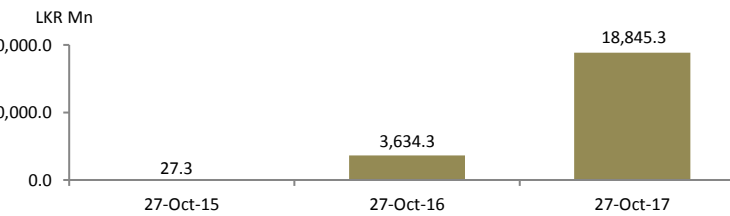
Positive and Negative Contributors to ASPI
